THE FOURTH AMENDMENT



How do the Feds have our Medical Records?

- ❖ Arizona Attorney General Mark Brnovich, penned a letter to President Biden on July 6.
- ❖ In the letter, Brnovich said he, along with many other Arizonans, had been “greatly alarmed by your White House indicating it might be in possession of medical records revealing the contact information of Americans who have not been vaccinated.” “If this is the case,” he wrote, “this is a severe breach of privacy, and I will not tolerate such intrusions within Arizona.”

The Answer - State Interposition

States should arrest Feds violating the Law

The Supremacy clause of Article VI.

- ❖ Supreme law of the land is:
- ❖ Constitution;
- ❖ Federal laws made under the authority thereof (“thereof” refers to Constitution);
- ❖ Treaties made under authority of United States.

- ❖ Alabama Judge Roy Moore warned Biden's operatives not to knock on his door because in Alabama "we dare defend our rights."

- ❖ But it also violates the Maryland State Constitution
- ❖ For Maryland to not interpose is to violate the State Constitution
- ❖ Tenth Amendment: “The powers not delegated to the United States by the Constitution, nor prohibited by it to States, are reserved to the States respectively, or to the people.”

The Contract We the People formed to created the government of the State of Maryland

- ❖ Our State Constitution provides even greater protections for our God given rights.
- ❖ Our State Constitution begins with the Declaration of Rights.
- ❖ These 47 Articles set forth the God given rights of the people and they are the very reason why the people brought this government into existence.

Declaration of Rights

- ❖ Article 1 states, “That all Government of right originates from the People, is founded in compact only, and instituted solely for the good of the whole; and they have, at all times, the inalienable right to alter, reform or abolish their Form of Government in such manner as they may deem expedient.”

Declaration of Rights

- ❖ Article 8. it states, “That the Legislative, Executive and Judicial powers of Government ought to be forever separate and distinct from each other; and no person exercising the functions of one of said Departments shall assume or discharge the duties of any other.”
- ❖ Various Public Safety Laws, particularly those dealing with the Governor’s Emergency powers do not change Art. 8 strictures.

The Oath of Office

- ❖ Each office holder swears upon oath before Almighty God “that I will support the Constitution of the United States; and that I will be faithful and bear true allegiance to the State of Maryland, and support the Constitution and Laws thereof; and that I will, to the best of my skill and judgment, diligently and faithfully, without partiality or prejudice, execute the office of _____, according to the Constitution and Laws of this State.”
- ❖ There is no exception clause in that oath.

Declaration of Rights

- ❖ Article 9. it states, “That no power of suspending Laws or the execution of Laws, unless by, or derived from the Legislature, ought to be exercised, or allowed.”
- ❖ So clearly the Governor has no authority to suspend any law which is constitutional and legitimated passed and signed into law.

Declaration of Rights

- ❖ Article 24. states, “That no man ought to be taken or imprisoned or disseized of his freehold, liberties or privileges, or outlawed, or exiled, or, in any manner, destroyed, or deprived of his life, liberty or property, but by the judgment of his peers, or by the Law of the land.”
- ❖ Thus our State Government should arrest all Federal agents who come into our State to violate these God given rights.

Declaration of Rights

- ❖ Article 36. states, “That as it is the duty of every man to worship God in such manner as he thinks most acceptable to Him, all persons are equally entitled to protection in their religious liberty; wherefore, no person ought by any law to be molested in his person or estate, on account of his religious persuasion, or profession, or for his religious practice...”

Declaration of Rights

- ❖ Article 44. states, “That the provisions of the Constitution of the United States, and of this State, apply, as well in time of war, as in time of peace; and any departure therefrom, or violation thereof, under the plea of necessity, or any other plea, is subversive of good Government, and tends to anarchy and despotism.”

- ❖ There are many who are saying this crisis brings the necessity of this jab in the arm, but notice how constitutionally that doesn't hold water. Any plea that this crisis is greater than any other denies this clear statement. "The provisions of ...this State [Constitution], apply, as well in time of war, as in time of peace; and any departure therefrom, or violation thereof, under the plea of necessity, or any other plea, is subversive of good Government, and tends to anarchy and despotism."
